A regular meeting of the City Council of the City of Arnegard was called to order at 7:00 p.m. on Monday, June 13, 2016, at the Arnegard City Hall, by Mayor Jeffrey Kindel.

Mayor Kindel gave a verbal report. Has been a quiet month.

Member Bjornstad gave verbal report. Ordinance Committee met regarding chickens in town. Committee decided after much opposition from the residents that the Ordinance will stand as written.

Member Lane addressed the City Council and all in attendance. Statement as follows:

“I have been on this Council for two years now, elected by the City and not any one individual. It has been my honor always, but not always my pleasure to serve this City. So before my term is over I would like to address several things that have happened over the two years that I have been here. Please be advised that what I am going to say are my thoughts, my feelings and my observations. They do not represent any one else here, just me. So if you have a problem with what I am going to say I will give you my number after the meeting. I was contacted by several people of this community to run for City Council and although I was concerned that I may not be qualified, I was told that if I cared about the community I was qualified. I put my name into the ring, following protocol and I was surprised as everyone else that I won. This Council has been audibly attacked, mocked, ridiculed, sworn at and on occasion have been treated with a very disturbing lack of respect. This is unacceptable. If you have something to say, come to the Council meeting, use your five minutes. If you can't cover it in five minutes, put yourself on the agenda, and the Council will listen to everything you have to say and consider it.

Two years ago we had a woman come to the City Council that was complaining because her young girl almost got hit in the face by fireworks that drunks were shooting off. The next year when we voted not to have a beer tent, we were crucified. We were told by some members that we should put our beliefs aside and do what's best for the community. That very night there was an accident down at the ball field, some drunk fell off of a vehicle and ended up in ICU. I can very happily say this Council was not responsible for that. I can also let you know I will never put aside my beliefs, my moral ethics to make someone else happy. You're never going to make everyone happy. You choose your decisions; you make your decisions according to what is best for the City. If your using the City's money, if you are talking about the City Ordinances, again you're not going to please everyone, you have to do what you think is right. We were criticized, crucified over the PDQ. We have rules for a reason, just like laws, everyone has to abide by them. Regardless if someone's father is in bad health, guess what mine is in bad of health as they come, doesn't make me any less responsible to follow the laws and regulations. If you follow the rules for everybody, if you follow the rules for every construction company, every bar, every coffee shop, every business, you will never have your ethics pulled into the view of

the people to be criticized, you will know that you did what you should have done because you did it the same way for everybody else.

I can tell you my biggest concern is this, and this is where I can already feel it coming on. This City is very kind to its citizens; it is very good to its citizens. It lets people come here every single day that they want to come have coffee, and visit and play cards and have a big time. What is absolutely unacceptable to me and should be to everybody else, is allowing people to sit in this room and criticize the Mayor, the Auditor, the Engineer, the Attorney, the Council and tear down citizens of this County and this City. If you want to crucify people on the Council, people making decisions for this City, take it down the street, take it to your house, get on the phone, but don't do it under this roof. I will say this, to the citizens of Arnegard I ask you...make your own decisions, do not be led through life and your decisions by angry, bitter, vengeful people. If you're going to sit around here, say something nice, get a different hobby, choose something good to do for this City instead of tearing it down. For those of you that are left, the citizens that coming in, the Council members that are coming in, you are going to have to have compassion for people that are hurting, but don't make your decisions based simply on compassion, make your decisions according to what the Ordinances say and what the laws say. That is your responsibility. If you think that coming on the Council is a way to sway this City to do whatever you want to do, that is incorrect. I have learned a lot while I was here. It has stressed me beyond belief, but it is worth it. I love this City, I chose to come here, I choose to stay here, and I want the best for this City just like all of you that have been here all your lives. Thank you."

Chief White Owl gave a verbal report.

Maintenance Worker Haight gave a verbal report.

Park District Maintenance Worker Faulkner gave a verbal report. Moving forward on the siding for the buildings and it will all be done by the Fourth of July.

New Business:

Mayor Kindel presented Ordinance 130, an Ordinance amending Article 3 and Article 5, of 'Chapter Four' of the Ordinances of the City of Arnegard, relating to Fire Protection and Prevention. Discussion was held. Motion made by Bjornstad, seconded by Homiston, to approve the second reading of Ordinance 130, as presented. Roll call: Bjornstad – Yes; Homiston – Yes; Lane – Yes. Motion carried.

Mayor Kindel presented Ordinance 131, an Ordinance amending Article 2 of 'Chapter Eight' of the Ordinances of the City of Arnegard relating to Business Regulations and Licenses. Discussion was held. Motion made by Bjornstad, seconded by Lane, to approve the second reading of Ordinance 131, as presented. Roll call: Bjornstad – Yes; Lane – Yes; Homiston – Yes. Motion carried.

Mayor Kindel opened a public hearing regarding a Conditional Use Permit request from Thompson Development, LLP at 7:27 pm.

No comments from the public.

Public Hearing closed at 7:59 p.m.

Motion made by Bjornstad, seconded by Lane, to approve the Conditional Use Permit request from Thompson Development, LLP, pertaining to the dwelling for a designated manager. Roll call: Bjornstad – Yes; Lane – Yes; Homiston – Yes. Motion carried.
