Mayor Kindel presented Resolution No. 2017-33, a Resolution approving the findings of the landfill leachate study/review work and directing staff to write a discharge permit to McKenzie County landfill. Discussion held. Motion made by Mosby, seconded by Nelson, to approve Resolution No. 2017-33, as presented. Roll call: Mosby – Yes; Nelson – Yes; Bjornstad – Yes; Moody – Abstain. Motion carried.

Mayor Kindel presented Resolution No. 2017-34, a Resolution approving the wage increase for the Police Officer. Discussion held. Member Nelson stated that he feels that the City of Arnegard should get rid of the Police Department. Motion made by Bjornstad, but died due to a lack of a second.

Discussion was held in regards to the City obtaining its own City Garbage truck.

Discussion was held on the amended floor plan and digital sign requested from the PDQ Club. Motion made by Nelson, seconded by Mosby, to approve the amended floor plan with the stipulations of the placement of minors not allowed signs, minors out by 10 pm, alcohol not mixed or stored in restaurant areas and that minors are not allowed to play any games or participate in karaoke. Also Steve Williams will be contacted in regards to the concerns and recommendations of the patio area. Roll call: Nelson – Yes; Mosby – Yes; Moody – Yes; Bjornstad – Yes. Motion carried.

Motion made by Moody, seconded by Mosby, to adjourn said meeting at 9:37 pm. Roll call: Ayes: 4 Nays: 0. Motion carried.
